However, on occasions he did drive with one hand on the steering wheel, and the other on the gearstick. (But had total car control).

Space management in urban traffic was excellent; Steve also makes good use of mirrors when changing speed and direction. On Dual Carriageways/Motorways he is also a very confident driver.

## General overview:

During the session it was really good to see Steve demonstrating a very well controlled drive. His use of mirrors are natural and not once did Steve exceed any speed limits. The main body of the training today covered a range of advanced driving techniques including the system of car control, which helped Steve approach hazards in a more systematic, safer way. We also looked at the limit point to enable him to improve his smoothness, stability and safety on more challenging rural roads.

Steve's awareness, anticipation and general all round drive in urban ,dual carriageways and motorways was trouble free (Apart from warning top top up washer fluid), the techniques covered today did add a final polish to his drive. We did cover commentary driving on today session, this really helped Steve further expand his field of observation and overall planning. Commentary driving does take practice, and I recommend Steve makes time to do this on a regular basis.

I would say that Steve is definitely considered a low risk driver. As long as Steve keeps driving to the same standard he drove today, he should continue to have many trouble free years of safe motoring ahead of him.
