## General overview:

Mirrors Need to check each time before changing speed or your direction and take in the information. Remember looking but not seeing take in the information so making better decisions.

Signals - only give signals from the Highway Code if that would help benefit other road users, and not to invite other road users into the road, think about the timing of the signals and only give the correct signal that is needed at the time.

Position Need to plan well ahead looking for road and traffic signs scanning by moving your eyes and make links, so giving yourself time, so that it would help you to understand which lane you need in good time.

Speed Be aware of the speed limit on the road and for your vehicle, remember speed limits and not targets drive and adjust to the conditions. Speed limits are for your and other road users safety.

Acceleration - remember to be used smoothly gradually build up your speed and deceleration when needed remember to use smoothly so having gradual build-up of speed and stabilising the vehicle when on Bends.

Overall, Rob has a very good attitude and was willing to learn new methods we had spoken about the risk involved in driving, and he need to be aware of his actions on the road and how it could affect other vulnerable users including pedestrians and motorcyclist.

Rob took on board what we have spoken about and try to implement the changes into his drive. I feel with over the years he has picked up some habits that may take time to correct if he works on these habits over the next few weeks and months, I am sure he will improve his driving and make him a better driver it is now time for him to start to implement some of the points which were raised in his drive.
