Claire, you were asked to attend this driver training session at your place of work, XXX, as you were now going to be commuting to various locations using the work van as a mode of transport. You told me that you had held a clean, full UK licence for around 6 years and were confident with driving your car but did not feel too confident with driving a van in and out of the city or carrying out a reversing manoeuvre.

At the start of the training session, we carried out a licence check, eye check, and basic vehicle maintenance check, all of which were adequate. You did have some good knowledge of vehicle checks, as you were shown these previously at your place of work.

General overview:

On our initial drive, I noticed that you were feeling a little bit uneasy driving the van due to its size and lack of interior mirrors. I explained that it would be a good idea to look at the left mirror, ahead, and then the night mirror. This would ensure that we were in a good road position. I also explained that before and whilst going left, glance at the left mirror, and the same for going right. We practised using mirrors and cornering in a tight housing estate.

You were quite happy to glance at the mirrors whilst driving and cornering to ensure that you knew where the van was at all times. This did improve our cornering and road position very well.

We did spend some time reversing the vehicle into a parking space as you did not feel confident reversing a van. I showed you how to set up stopping reference points, where to look while reversing, and that if you carry out reversing very slowly, it will ensure full observations around us, which would increase vehicle safety.

You managed to build confidence by reversing and showed that you could park the van independently in a parking space while carrying out full observations.

On our next drive, you were keeping a good road position, checking around more frequently, confident with roundabouts, driving in an eco-safe manner, aware of other road users, aware of speed limits and driving within these limits at all times. Overall, your van driving did improve greatly; you were now showing more confidence with reversing and manipulating tight areas by checking your surroundings more frequently. Keep up the good work, and if you feel that more reversing practice will help, please ask for more practice, as this will increase your confidence even more.

Overall Driver Risk:

Low Risk - The driver is considered low risk, with only a few very minor issues identified during the session, which were highlighted.

Medium Risk - The driver is considered medium risk, with a few potentially serious issues, which were highlighted during the session. A conscious effort must be made to practise what has been suggested during the session, to ensure they become low risk.
