General overview:

During the session, we incorporated a wide variety of roads including urban and motorway.

We paid particular attention to the use of mirrors to ensure that he was fully aware of any other road users which may be behind and also to ensure that the path of the rear wheels was not coming into conflict with any other road users or any street furniture (i.e. kerb edges). As the session progressed, he began to do this more independently with less prompting from myself.

Adam initially was rushing through gear changes without listening to the engine or planning ahead and as a result was changing gears too early, leaving the vehicle struggling. We had a conversation about the handling and the fact that in order to move a vehicle of this size he would need to hold the lower gears a little longer and listen to the engine before changing gears automatically as he would do in his own car And as the session continued, he became more in tune with the vehicle and it needs.

We discussed the need to extend observations further down the road and plan ahead more with particular reference to traffic lights or timing the approach to junctions and roundabouts.

Overall, Adam embraced the training and took on board any hints or tips given.
